## Remarks 備註

- (1) Registration of an instrument under the Land Registration Ordinance shall be effected by delivering into the Land Registry such instrument together with a memorial thereof in the form specified and provided by the Land Registrar and by compliance with the Ordinance and subsidiary legislation. 根據《土地註冊條例》(“該條例”)進行的文書註冊，須依照下述的規定達成：將該文書連同該文書的註冊摘要，以土地註冊處處長所指明和提供的格式交付土地註冊處，並須符合該條例及附屬法例的規定。
- (2) The purposes of the land records are to prevent secret and fraudulent conveyances, and to provide means whereby the titles to real and immovable property may be easily traced and ascertained. Any information, including personal data, contained in instruments and memorials lodged for registration will appear in the public land registers kept by the Land Registry. All documents are open for public search and inspection. Please ensure that all practicable steps are taken to comply with Principle 1(3) in Schedule 1 of the Personal Data (Privacy) Ordinance by informing the data subjects that upon registration of documents in the Land Registry the personal data contained therein will become open to public search and inspection. 土地紀錄的用途是防止秘密及有欺詐成分的物業轉易，以及提供容易追溯和確定土地財產及不動產業權的方法。交付註冊的文書和註冊摘要內載的任何資料，包括個人資料都會顯示在土地註冊處備存的公眾土地登記冊內。所有文件都公開給市民查閱。請確保採取所有切實可行的措施，以符合《個人資料(私隱)條例》附表1第1原則第3項的規定，即告知資料當事人文件一經在土地註冊處註冊，文件內載的個人資料即可公開供市民查閱。
- (3) Please specify in the memorial the solicitors code of the solicitor/solicitors firm by whom the instrument was delivered. The Land Registry will return the instrument to the solicitor/solicitors firm concerned in accordance with the code. 請在註冊摘要註明交付文書的律師/律師行的律師代號，土地註冊處會根據代號把文書交還有關的律師/律師行。
- (4) Address should include the name of the street and the number of the premises. Please specify “Official address not yet known” if such particulars are not shown on the land register. If the address in Chinese is not known, please specify “Chinese address not known” in the memorial. 地址應包括街道名稱及物業門牌號數。如土地登記冊沒有顯示該等資料，請註明「正式地址未詳」；如中文地址不詳，請在註冊摘要註明「中文地址不詳」。
- (5) For plan that is larger than A3 size, please attach a copy to the memorial. 如圖則大於 A3 尺寸，請把圖則副本附於註冊摘要。
- (6) If space is insufficient, please show particulars with references on a separate sheet stapled onto this form. 如不夠空位填寫詳情，請另頁填寫並註明參照資料，然後把附頁與本表格釘在一起。
